Budgetary Information: The City of Livingston, KY has offered \$4,400 for the purchase of two former patrol vehicles with equipment from the City of Sandusky. In addition to obtaining the maximum return to the city for the sale, it is our desire to support and cooperate with other governmental entities, especially during the current economical conditions.

ITEM FOR CONSIDERATION: Legislation declaring two used police vehicles as being unnecessary and unfit for City use and authorizing entering into an agreement with the City of Livingston, Ky. for the sale of a 2005 Chevrolet Impala (VIN #2G1WF55K459165152 / approx. 152,000 miles), a 2003 Ford Crown Victoria (VIN #2FAFP71W23X216610 / approx. 194,000 miles) and equipment which includes interior containment packages, light bars, siren units and radios.

BACKGROUND INFORMATION: The City of Sandusky owns a 2005 Chevrolet Impala and a 2003 Ford Crown Victoria that were used as marked patrol vehicles by the City's Police Department. These vehicles are two of the seven recently replaced patrol vehicles. These vehicles are not needed and have exceeded their expected service life. The equipment that will be included is surplus, as new modern equipment has been purchased and installed recently in our Patrol vehicles. The General Services Director and Fleet Maintenance Supervisor have made these recommendations.

The Livingston Police Chief, Carl Swanigan, used to work for the Sandusky Police Department in the 1980's and has known Interim Chief Lang for many years. Chief Swanigan was recently in Sandusky and being aware that we had purchased new police vehicles, inquired about purchasing some of our used vehicles that were going to be disposed of for his police department in Livingston.

BUDGETARY INFORMATION: The City of Livingston, Ky. has offered \$4,400.00 for the purchase of two former patrol vehicles with equipment from the City of Sandusky. The City of Livingston Ky. is starting a new program and needs marked vehicles. The Fleet Maintenance Supervisor and Director of General Services have determined that this is a fair price and better than what would be expected if the vehicles and equipment were auctioned on Gov Deals.Com and are recommending the sale of the vehicles and equipment to the City of Livingston Ky.. In addition to obtaining the maximum return to the City for the sale, it is our desire to support and cooperate with other governmental entities especially during the current economical conditions.

ACTION REQUESTED: It is requested that the proper legislation be prepared declaring the 2005 Chevrolet Impala, 2003 Ford Crown Victoria and equipment as being unnecessary and unfit for City use and authorize an agreement to sell the 2005 and 2003 vehicles and equipment to the City of Livingston, KY. It is also requested that this legislation be passed under suspension of the rules and in accordance with Section 14 of the City Charter to allow the City of Livingston to take ownership of the vehicles and equipment at the earliest opportunity and promptly implement their new program.

ORDINANCE NO. _____

AN ORDINANCE DECLARING THE 2005 CHEVROLET IMPALA AND 2003 FORD CROWN VICTORIA AS BEING UNNECESSARY AND UNFIT FOR CITY USE PURSUANT TO SECTION 25 OF THE CITY CHARTER, AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT FOR ITS SALE TO THE CITY OF LIVINGSTON, KENTUCKY; AND DECLARING THAT THIS ORDINANCE SHALL TAKE IMMEDIATE EFFECT IN ACCORDANCE WITH SECTION 14 OF THE CITY CHARTER.

WHEREAS, the City of Sandusky owns a 2005 Chevrolet Impala, 2003 Ford Crown Victoria, and equipment which includes interior containment packages, light bars, siren units and radios, that were used by the Police Department and recently replaced that have exceeded their expected service life and are no longer needed and the General Services Director and Fleet Maintenance Supervisor are recommending that these vehicles and equipment be declared unnecessary and unfit for City use; and

WHEREAS, Section 25 of the City Charter authorizes the City Manager to sell personal property that the City Commission may authorize to be sold as having become unnecessary and unfit for City use; and

WHEREAS, the City of Livingston, Kentucky, has offered \$4,400.00 for the purchase of the 2005 Chevrolet Impala, 2003 Ford Crown Victoria and equipment and the General Services Director and the Fleet Maintenance Supervisor have determined that this is a fair price and an excellent opportunity to obtain the maximum return to the City and in addition given our current economical climate desire to support and cooperate with other governmental entities and are recommending the sale of these vehicles and equipment to the City of Livingston, Kentucky; and

WHEREAS, this Ordinance should be passed as an emergency measure under suspension of the rules in accordance with Section 14 of the City Charter to allow the City of Livingston, Kentucky, to take ownership of the vehicles and equipment at the earliest opportunity and promptly implement their new program; and

WHEREAS, in that it is deemed necessary in order to provide for the immediate preservation of the public peace, property, health, and safety of the City of Sandusky, Ohio, and its citizens, and to provide for the efficient daily operation of the Municipal Departments, including the Department of General Services of the City of Sandusky, Ohio, the City Commission of the City of Sandusky, Ohio, finds that an emergency exists regarding the aforesaid, and that it is advisable that this **Ordinance** be declared an emergency measure which will take immediate effect in accordance with Section 14 of the City Charter upon its adoption; and NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SANDUSKY, OHIO, THAT:

Section 1. This City Commission finds and determines that the 2005 Chevrolet Impala, VIN No. 2G1WF55K459165152, 2003 Ford Crown Victoria, VIN No. 2FAFP71W23X216610, and equipment which includes interior containment packages, light bars, siren units and radios, are unnecessary and unfit for the City use pursuant to Section 25 of the City Charter and authorizes and directs the City Manager to enter into a contract with the City of Livingston, Kentucky for the sale of the 2005 Chevrolet Impala, 2003 Ford Crown Victoria and equipment for the price of Four Thousand Four Hundred and 00/100 Dollars (\$4,400.00), substantially in the same form as Exhibit "A", a copy of which is attached to this Ordinance and is specifically incorporated as if fully

rewritten herein, together with such revisions or additions as are approved by the Law Director as not being adverse to the City and as being consistent with carrying out the terms of this Ordinance.

Section 2. If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section 3. This City Commission finds and determines that all formal actions of this City Commission concerning and relating to the passage of this Ordinance were taken in an open meeting of this City Commission and that all deliberations of this City Commission and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. That for the reasons set forth in the preamble hereto, this Ordinance is hereby declared to be an emergency measure which shall take immediate effect in accordance with Section 14 of the City Charter after its adoption and due authentication by the President and the Clerk of the City Commission of the City of Sandusky, Ohio.

CONTRACT FOR SALE OF PERSONAL PROPERTY

This Agreement made on and entered into this _____ day of _____, 2011, between the City of Sandusky, Ohio, a Chartered Municipality of the State of Ohio, 222 Meigs Street, Sandusky, Ohio 44870, hereinafter referred to as "Seller" and the City of Livingston Police Department, 9224 Main Street, P.O. Box 654, Livingston, Kentucky 40445, hereinafter referred to as "Buyer".

WHEREAS, the City of Sandusky currently owns a 2005 Chevrolet Impala (VIN #2G1WF55K459165152), a 2003 Ford Crown Victoria (VIN #2FAFP71W23X216610) and equipment which includes interior containment packages, light bars, siren units and radios which are no longer necessary and not needed for any municipal purpose as found and determined by the City Commission of Sandusky and contained in Ordinance No. _____, passed on _____; and

WHEREAS, pursuant to Section 25 of the Charter of the City of Sandusky and the laws of the State of Ohio, the City Manager is authorized to sell personal property that the City Commission authorizes to be sold as having become unnecessary and unfit for City use; and

WHEREAS, it is the desire of the City of Sandusky to obtain the maximum return to the City for the sale of the 2005 Chevrolet Impala, 2003 Ford Crown Victoria and equipment which includes interior containment packages, light bars, siren units and radios and simultaneously recognize the need for support and cooperation between governmental entities; and

NOW, THEREFORE, The Buyer and Seller agree as follows:

ARTICLE 1. RECITALS

NATURE OF CONTRACT

This is an Agreement for the sale of a 2005 Chevrolet Impala (VIN #2G1WF55K459165152), a 2003 Ford Crown Victoria (VIN #2FAFP71W23X216610) and equipment which includes interior

containment packages, light bars, siren units and radios between the City of Sandusky (Seller) and the City of Livingston, Kentucky (Buyer). This Agreement was authorized to be executed by the City Commission of the City of Sandusky, Ohio, by Ordinance No. _____, passed on _____, and this Agreement was executed on the _____ day of _____, 2011, at Sandusky, Ohio.

GOVERNING LAW

The Seller and Buyer acknowledge and agree that the Laws of the State of Ohio will control all aspects of this Agreement and its interpretation.

INTEGRATED AGREEMENT

The terms contained in this Agreement are intended by both Buyer and Seller as a final expression of the terms of their Agreement and are a complete and exclusive statement of those terms.

ARTICLE 2. PERSONAL PROPERTY

NATURE OF PERSONAL PROPERTY

The personal property that is the subject matter of this agreement is the following: A 2005 Chevrolet Impala (VIN #2G1WF55K459165152), a 2003 Ford Crown Victoria (VIN #2FAFP71W23X216610) and equipment which includes interior containment packages, light bars, siren units and radios.

ARTICLE 3. PERSONAL PROPERTY SOLD "AS IS"

DISCLAIMERS OF WARRANTIES

The Buyer acknowledges and represents that the Buyer is buying the 2005 Chevrolet Impala (VIN #2G1WF55K459165152), 2003 Ford Crown Victoria

(VIN #2FAFP71W23X216610) and equipment which includes interior containment packages, light bars, siren units and radios, which is the subject of this agreement "as is". The Seller makes no warranty or representation about the performance ability of the used 2005 Chevrolet Impala, used 2003 Ford Crown Victoria and used equipment which includes interior containment packages, light bars, siren units and radios, about its present state of repair, about its condition or maintenance, or about its ability to function in any respect. In executing this agreement, the Buyer has not relied on or been induced by any statements or representations, other than those expressly set forth in this agreement, of any person in respect to the physical condition of the used 2005 Chevrolet Impala, used 2003 Ford Crown Victoria and used equipment which includes interior containment packages, light bars, siren units and radios or any other matter affecting the used 2005 Chevrolet Impala, used 2003 Ford Crown Victoria and used equipment which includes interior containment packages, light bars, siren units and radios that might be pertinent in considering the purchase of the used 2005 Chevrolet Impala, used 2003 Ford Crown Victoria and used equipment which includes interior containment packages, light bars, siren units and radios or the execution of this agreement. The Buyer acknowledges that no such representations not embodied in this agreement have been made. The Buyer has relied solely on the representations made in this agreement and on such investigations, examinations, and inspections as the Buyer has made. The Seller has afforded the Buyer the opportunity for full and complete investigations, examinations, and inspections.

ARTICLE 4. PRICE

TOTAL PRICE

The price for the personal property that is the subject matter of this agreement is: Four Thousand Four Hundred and 00/100 Dollars (\$4,400.00).

PAYMENT FOR PERSONAL PROPERTY

Payment for the personal property is due from the buyer on tender of delivery by the seller.

ARTICLE 5. DELIVERY

PLACE OF DELIVERY

The place for delivery of the personal property sold under this agreement is the seller's place of business at 1024 Cement Avenue, Sandusky, Ohio 44870.

The personal property shall be delivered to the Buyer at a mutually agreed upon time, on or before _____, 2011 at which time the buyer shall pick-up the personal property.

RIGHT TO INSPECTION

The Buyer has the right to inspect the personal property before delivery is considered complete under this agreement. The inspection may take place only at the place and time for delivery.

ARTICLE 6. REMEDIES AND LIABILITIES

ALLOCATION OF RISK

Any risk associated with the sale of the personal property rests with the Seller up to the time the buyer receives the personal property at the place of delivery and completes a proper inspection without rejecting the

personal property. After delivery and inspection, the risk is with the Buyer including any risk associated with returning the personal property to the Seller. After the Buyer has returned the personal property to the Seller and the Seller has received the personal property, any risks associated with the personal property revert to the Seller.

REJECTION OF NONCONFORMING PERSONAL PROPERTY

Any rejection of the personal property must be made by the buyer at the time of delivery and inspection by the buyer.

EXCLUSIVE REMEDY OF BUYER

The exclusive remedy of the buyer under this agreement is to return the personal property and the return of the purchase price for the personal property.

EXCLUSIVE REMEDY OF SELLER

The exclusive remedy of the Seller under this agreement is to have the personal property returned.

ARTICLE 7. ASSIGNMENT

Neither the Seller nor the Buyer may assign any portion of this agreement without the prior written consent of the other, which consent shall not be unreasonably withheld.

ARTICLE 8. EFFECT OF AGREEMENT

PARTIES BOUND

This agreement shall be binding on and inure to the benefit of the parties and their respective heirs, executors, administrators, legal

representatives, successors, and assigns when permitted by this agreement.

LEGAL CONSTRUCTION

In case any one or more of the provisions contained in this agreement are held to be invalid, illegal, or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect any other provision and this agreement shall be construed as if the invalid, illegal, or unenforceable provision had never been contained in it.
