Sealed proposals will be received by the City of Sandusky in the Law Department, 222 Meigs Street, Sandusky, OH 44870 until Tuesday, December 20, 2011 at 3:00 P.M. (EST) for the sale of residential real property located in the City of Sandusky, Ohio. The property is located at 1631 Campbell Street, Erie County Permanent Parcel No. 57-00945.000 and consists of one (1) residential two-story structure with three (3) bedrooms, one (1) bath and one (1) detached garage with a lot size of approximately 33' X 128'. The property is zoned R2F (Two-Family Residential) and shall be owner-occupied.
